Old Business:

- 8a. Uncover the Leader in You has been cancelled, should we try for Knowledge College and Leader Learning Day? Discussion held if enough interest for Knowledge College in our region, we would be looking at a March/April date, also need suggestions/topics for this.
- 8b. Pam Gitzel reviewed the 2121-2022 Regional Program Plan.
 - more info will be coming on the hockey game with the Oil Kings.
- 8c. Scholarships (1.) Bertha K
 - the committee met virtually and chose three \$500.00 scholarship winners for NW region
 - should we go back to previous years format of writing essays and give 2 for Safety and 2 for NW region on pledge/motto essay, cost would be \$2,200.00
 - at the executive meeting we budgeted \$100.00 for admin fee not \$200.00
 - scholarships were budgeted from the casino account and admin fee from the general account
 - if we combined all four under one name would we only have one admin fee?
 - \$2.00 per member will be collected for scholarships this year

CW moved we pay the extra \$100.00 admin fee from the general account for 2022 and let the scholarship committee decide which way scholarships will go and under what umbrella. Seconded by CP. Carried

- 8d. Regional items to give away
 - Leslie M helped make list, some items are gone already, the dishes, cutlery etc. will be going to Camp Nakamun
 - other items will be used for record book and communication awards also this year

New Business:

- 9a. Northwest Regional Budget (2)
 - Sonja S shared her screen and went over budget requests
 - discussion was held on camp budget requests, question on Camp Nakamun's position on Covid vaccinations, an Loon with camps
 - NW region has paid money from the casino account for facility rental already, what is the number of campers we need for camp to go ahead
 - Lifeskills budget discussed, they have meeting on November 26, 2021. CP made a
 motion that casino funds are not used to cover any money for Lifeskills fair until Lifeskills moves
 their funds to the Regional account. BK seconded. Vote was held on this motion.

Opposed -11, In favor -18, motion is passed.

LM moved membership to approve budget as presented for 2021-2022. Seconded by BK. Carried

- 9b. Accounting Program:
 - program has expired, has been paid by Sonja S for last couple months until meeting
 - Sage subscription about \$15.00 per month, Quikbooks the same, new treasurer's decision which one to use

LM made a motion that the NW Region cover up to \$200.00 per year for an accounting program of treasurer's choice. Seconded by BK. Carried

Pam Gitzel commented that there maybe a group licensing premium for Quikbooks through the 4-H Alberta office.

Beef -1st and 2nd in market steer and breeding heifer books in levels Jr., Int., and Sr. for a total of 12 awards

Lifeskills – 1^{st} and 2^{nd} in lifeskills and other animals in levels Jr., Int., and Sr. for a total of 12 awards Horse – 1^{st} and 2^{nd} in horse in levels Jr., Int., and Sr. for a total of 6 awards

- Leslie M questioned if marking committee could do a 3rd place book and the district would cover the cost?

LM made a motion that the Region cover the costs of $15 - 1^{st}$ place and $15 - 2^{nd}$ place record book awards for horse, lifeskills and beef books. Seconded by LH. Carried
