1. Call to Order - Andy Pittman

9.2. Election

Everyone voted. Scott Bodie & Kathleen Linder were the scrutineers for the election, 24 votes in favor, none opposed.

9.3. Election Results

Scott Bodie presented the election results. The slate of nominees for 2023 was accepted. I, Tanya Reist move that the electronic ballots for the 2023 election of Directors be destroyed: Seconded by Juanita Wagstaff. All in favor. Carried. Chair, Andy Pittman welcomed the new Board Directors.

10. 4-H Alberta Bylaws Amendments - Scott Bodie

Scott Bodie presented the amendments to the 4-H Alberta Bylaws.

- Clarification was requested regarding 5.04 in the Blackline Proposed Changes.
- Point raised that both East and West Central to each have their own Director.

I, Scott Bodie, move that we approve the amended 4-H Alberta Bylaws as presented with the exception to the amendment to 5.04. Seconded by Kathleen Linder . All in favor by show of hands. Motion carried.

I, Scott Bodie move that we approve the proposed amendment to Bylaw 5.04 as presented. Seconded by Tanya Reist. Vote by show of hands: 14 in favor, 6 opposed. Motion carried.

Paul Franz asked: now that the motion has been approved can an amendment be made to state that if the regions are unable to come to a decision or a split decision is reached due to multiple candidates the Governance and Nominating Committee will choose the best candidate for that position? Chair, Andy Pittman stated this will be added to the agenda for the next regional gathering.

11. Thanks to Retiring Director - Andy Pittman

Andy Pittman thanked the Alberta Government for the grant dollars, the retiring directors, Lyanne Almberg, for her years of service on the 4-H Alberta Board.

12. Looking ahead to 23/24 - Andy Pittman

Andy Pittman commented on the upcoming year. The priorities for the board include good governance, meeting with Regional Chairs, hosting a Regional Gathering, and listening to volunteers and 4-H members.

13. Questions - previously submitted

Kurt Kinnear commented on volunteer burnout and staff related questions.

Andy Pittman answered a question about having another Regional Gathering similar to the one that was hosted in January 2022.

14. Closing Comments and Adjournment - Andy Pittman
